History of Pike County, Missouri (1883)

Page 304 Official Record of Company D, Twenty-Third\* Regi-  
ment Missouri Voluntary Infantry.

James BUNN appointed corporal Sept. 5, 1862; sergeant, July  
27, 1863; died at Memphis, Tennessee, Dec. 23, 1862.\*

From this he appears to have been promoted to sergeant post-  
humous.

A check of the 1850 Missouri Census Index does not reveal  
any BUNN families in the State of Missouri. Yet the 1860  
Pike Co. Census shows James BUNN, age 28 and born in Missouri.

Henry S. Carroll, who kept a diary, was first sergeant and called the  
roll of the company daily (Often three to five times each day) from  
Dec. 5, 1862 to Jan. 6, 1864, with the exception of his absence while  
on a 30 day furlough.

Men for the Thirty-third Missouri Volunteer Infantry, Company D, were  
enlisted in July and August, 1862. They were mustered into United  
States service at Benton Barracks, St. Louis, Missouri, August 30,  
1862.

Page 297 The command remained at Fort Curtis as garrison until January  
28, 1864. The battle for Fort Curtis took place July 4, 1863

\* These appear to be errors in the history referred to here, and should  
be the Thirty-third Regiment, not Twenty-third, which is referred to in  
other parts of the history of Pike County.

Also if Corporal James Bunn had died in December of 1862 why was he pro-  
moted to sergeant in July of 1863 as it appears in the history?

James Bunn's military records from the National Archives have it recorded  
that he died in the Hospital at Memphis, Tennessee, 19 December 1864.
